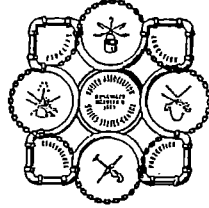

WAGE & FRINGE BENEFIT BOND

KNOW ALL MEN BY THESE PRESENTS, that we, _____

of the City of _____ (hereinafter called the Principal) and the

_____ Company, a corporation created and existing under the laws

of the State of _____, whose principal office is located in the City of

_____, State of _____ (hereinafter

called the Surety,) effective as of the date listed below, are held and firmly bound unto The Plumbers and Steamfitters Union Local #42 of Lorain, Erie, Huron, Ashland, Richland, Morrow, Knox, Crawford and Wyandot Counties, State of Ohio, in the full and just sum of THIRTY FIVE THOUSAND DOLLARS (\$35,000.00) for the first five (5) employees, or any part thereof, and SEVEN THOUSAND FIVE HUNDRED DOLLARS (\$7,500.00) for each employee thereafter, lawful money of the United States of America to the payment of which said sum of money, said Principal binds himself or itself, his or its heirs, executors, administrators, successors, and assigns and the said Surety binds itself, its successors and assigns jointly and severally by those present.

WHEREAS, said Principal, I under contract with the Plumbers and Steamfitters Union Local #42, of Lorain, Erie, Huron, Ashland, Richland, Morrow, Knox, Crawford and Wyandot Counties, State of Ohio, and made a part hereof as fully to all intents and purposes as if set out at length herein.

NOW, THEREFORE, the condition of the foregoing obligation is such that if the said Principal shall faithfully comply with all terms, covenants and conditions of said contract on his or its part to be kept performed in regard to the payment of contributions and/or Payroll Deductions of the Educational Trust Fund, Health & Welfare Trust Fund, Pension and Retirement Trust Funds, Dues Checkoff System, and Wages provided for in said contract then this obligation shall be null and void: otherwise to be and remain in full force and effect.

This bond may be cancelled by the serving of 30 day written notice by the Surety, such service to be sent by registered mail to the last known address of the obligee.

AGREEMENT FOR VOLUNTARY RECOGNITION

This Agreement for Voluntary Recognition made and entered into as of this _____ day of _____, within the jurisdiction of PLUMBERS AND STEAMFITTERS LOCAL 42 (hereinafter "Union"), being Lorain, Erie, Huron, Ashland, Richland, Morrow, Knox, Crawford and Wyandot Counties in Ohio, and _____ (hereinafter referred to as "Employer").

The Union has presented authorization cards which were voluntarily signed by a majority of the employees in the Employer's workforce, clearly establishing that the Union has majority support among the unit of employees described below. Said cards have been examined and the original cards have been returned to the Union.

The parties hereto, in consideration of the mutual benefits to be derived from collective bargaining, for the purposes of securing closer cooperation among and between the Employer and the Employees, and in consideration of the promises, obligations and undertakings of each party as herein contained, agree as follows :

1. The Employer, based upon the above stated presentation and examination, agrees to recognize and does hereby recognize the Union, its agents, representatives or successors as the exclusive bargaining agent for all Employees performing plumbing and mechanical construction work within the jurisdiction of the Union on all present and future job sites. All Employees not performing said work are excepted from this recognition.
2. Employer agrees that it will not sponsor or promote, financially or otherwise, any other labor group or organization for the purpose of undermining the Union, nor will it interfere with, restrain, coerce or discriminate against any of its Employees in connection with their membership in the Union.

The foregoing Agreement for Voluntary Recognition shall be and remain in full force and effect until such time as the Union is decertified after an election conducted by the National Labor Relations Board.
